






Cumulative Net Power Cost Budget vs Actuals (Original Budget Only): All





Gross Capital Expenditures by Category (Actuals)




Gross Capital Expenditures by Group (Actuals)











By Year for Revenue Class: All in Month: November




By Year for Revenue Class: **Residential** in Month: **November**




By Year for Revenue Class: Small General, Medium General, Large General in Month: November




