  - Applicant has at least 24 months of satisfactory payment record with Benton PUD, within the past 3 years
  - Applicant provides a reference in the same name from another electric utility reflecting satisfactory credit. The letter must verify at least 24 months of acceptable payment history within the past 3 years, for an account of a similar business nature.
  - A Benton PUD obtained credit report demonstrates proof of an acceptable nationally recognized credit rating of investment grade or higher.
  - In addition to the criteria above, Large General Service customers may be required to provide additional information to determine credit worthiness. Please refer to the Customer Service Policies for more information.
- \_\_\_\_\_ • When signing up for service at a new location, a Start Service fee will be added to the first monthly bill.
- \_\_\_\_\_ • Benton PUD policies and rates are approved by Benton PUD’s Commission and are the governing documents under which customers receive electric service from Benton PUD.
